Annual Meeting ... 1956.

The Annual Meeting of Taxpayers of Rocanville R.M. No. 151 met in the Memorial Hall on Monday, Oct. 22, 1956 with a good attendance of Taxpayers.

A call for nominations for chairman from the floor of the meeting was made as per usual custom, and Mr. A.J. Calder was chosen to preside at the meeting.

An outline of an agenda was read and adapted as the outline for the meetings items of business. Topics of discussion included : Veterinary Services district of the 3 R.M.s including Rocanville R. M. An outline of fees was to be available showing the charges by Dr. MacDonald re the various types of service. Also the matter of Tax Collections, and an announcement was made re the forthcoming Vote on Time Zones as conducted by the Provincial Government. The vote was to be held on the same day as Municipal elections, with the same Polls and Polling officials. Electors were being asked to vote on a choice of ONE Time Zone for the entire province or different time zones or different areas as at present.

There was considerable discussion re the matter of the Municipal Doctor Area in the Western part of the Municipality and also on the proposal for a survey re the M.S.I. plan. It was decided to try and ascertain the feeling of the ones in the Mun Dr. area as to their wishes in the matter of continuing with the Municipal Doctor contract in Western part of R.M.

A speaker from Medical Services Incorporated was in attendance at the meeting and gave a comprehensive outline of the costs and procedure in the matter of having the Rocanville Municipality come under the M.S.I. plan if so desired. A number of questions re same were answered, and the Chairman thanked the speaker for his address. It was decided to proceed as soon as possible in the matter of conducting a partial survey in the R.M. by a man from M.S.I. along with some of the Councillors, with the view of trying to find out how many might be interested in signing up with Medical Services.

At the appointed hour the Returning officer declared the meeting open for nominations for Councillors for Div. 1, 3 and 5 and for Reeve for a two-year term.

When nominations closed at 4.00 P.M. (Local time) it was announced that there was elected by acclamation, Mr. L. Gagnon in Div. 1, and Mr. J.W. Kydd in Div. 3. It was also announced that there would be a Poll for Reeve and for Councillor in Div. 5. The nominees were:

For Reeve: Alexander Calder, and Joseph Goodman;

For Councillor: Barney Kaplun and Arthur Pahkala.

The financial statement for the first 9 months of 1956 was given and received.

A Short address## were given by the Reeve (Mr. Calder) , and he thanked the electors for their support and promised to continue to give of his best ## re-elected. Thereafter the chairman called on the Councillors and ## nominees present for a few remarks. Reports of the work of the various divisions were given, followed by considerable discussion re roads and other problems, including report re some of the Agricultural Committee projects.

A report re Tax collections was given by the Secretary up to present date and on motion of Mr. Les McCutcheon the meeting adjourned at 5.00 P.M.
