MG-30

This season the RM top sealed and maintained the MG30 applied to the 719/601 Grid and Manitoba Road. The decrease in maintenance costs due to grading only a couple times per year along with the increased life expectancy of these roads make it an attractive option. This also allows greater visibility and therefore safety for the heavy traffic conditions of these roads.

Qu'Appelle Valley Bridge

The RM along with the RM of Spyhill received a grant from the Rural Integrated Roads for Growth to replace this Bridge. The paving for this bridge is scheduled for August—thus completing this project.

<u>Culverts</u>

The RM has been working with local construction companies to complete various culvert projects throughout the RM. This is important for the longevity of the roadway and to maintain the natural watercourse.

Road Work Planning

The RM is committed to long-term planning for future road construction. We are working towards a long term plan that will hopefully see 4-6 miles of road built/clay capped each year. We want to hear from you on which roads you think should be in the Plan!









Gravel Crushing

Council has awarded Tender to B.C.E. Earthworks for 40,000 yards to be crushed at the Mine Pit in August.

Taxation Changes

With the Physical Reinspection undertaken by the Saskatchewan Assessment Management Agency (SAMA) this year in our RM, Council has reviewed Taxation and introduced a Mill Rate Factor (MRF) Bylaw and Minimum Tax Bylaw. Please call your Councillor or the office if you have any questions.

- ♦ Mill Rate (MR) 11.0 Mills
- ♦ MRF (Ag 0.82, Res 0.6, Comm 0.9)

(Therefore the Effective Mill Rate will be MR x MRF)

Controlled Burns 1-866-404-4911

ALWAYS Report your planned controlled Burn! This will avoid fire trucks responding. If your burn is not reported, you will be invoiced for the cost of the Fire Department.

Water

Please be advised that the well water located on NW33-16-32 W1 is not treated or tested and is considered unpotable. DO NOT USE this water for drinking, cooking, food preparation, or hygiene purposes.

The Water from the RM yard in town is potable. Please see Administration to purchase a key fob for \$20.

Ratepayer Gravel

Ratepayers are entitled to 5 loads of gravel per farmyard per year at cost plus trucking. (For 2023: \$7/ yard + \$1/yd/mi hauling) Gravel delivery occurs usually on the first Monday and Tuesday of each month. Annual cut off may be dependent on weather.

Ratepayer Dust Control

FOR 2023: The RM charges ratepayers \$350 per 200m application of MG30 Dust Control. Dust Control orders need to be received by May of each year.

Road Allowance

The RM has a 99-foot Road Allowance on all roads. There shall be NO equipment, fences, farming, spraying, digging or items put on the right of way. Council may fine ratepayers found to be impairing the Right of Way via the General Penalty Bylaw of the Municipality. This Penalty is up to \$2,000 for Individuals and \$5,000 for Corporations. Council also has the right to Mow the Right of Way.

1971 Fire Truck

Council has decided to retain possession of the 1971 Firetruck to preserve history and have it available to the Community for Museum days and Parades as able.

Organic Farms

Please let the RM Office know if you farm organically and we can add this land to our Map and inform spraying companies upon request.

Drainage

Ratepayers must apply for approval to construct & operate drainage works under the Water Security Agency (WSC) or phone the Yorkton Office @ 1-306-786-1490.
